#### **Data Subject Application Procedure Notice for Private Data Process**

#### **How We Collect Personal Information and Legal Bases**

Your personal data is collected through the relevant person application form and petitions you submit via email channels, within the scope of fulfilling the Purposes specified above.

Your personal data is collected and processed by our Company for the following purposes and legal reasons, based on the conditions of processing personal data specified in Article 5 of the Law.

Based on the legal reason that it is mandatory for the data controller to fulfill its legal obligation and as explicitly stipulated by the laws;

• Evaluating and concluding your applications to the Company within the scope of exercising your rights specified in Article 11 of the Law regarding your personal data processed by our Company, and carrying out the necessary transactions within this framework,

- Retaining records related to your applications to our Company for the duration of the general statute of limitations for the purpose of serving as evidence in possible disputes that may arise in the future,
- Fulfilling requests from official institutions and providing information to authorized organizations as required by legislation.

Based on the legal reason that it is necessary to process data for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the related person;

We hereby inform you that you have the following rights under Article 11 of the Law regarding your personal data:

- To know the third parties to whom your personal data is transferred, domestically or abroad.
- To request the correction of your personal data if it is incomplete or processed inaccurately, and to request that the transaction carried out in this context be notified to the third parties to whom your personal data has been transferred,
- To request the deletion or destruction of your personal data in the event that the reasons necessitating their processing cease to exist, despite being processed in accordance with the Law and other relevant statutory provisions, and to request that the transaction carried out in this context be notified to the third parties to whom your personal data has been transferred.
- To request compensation for the damages in case you suffer damage due to the unlawful processing of your personal data.

Your data is not processed automatically in our systems.

In the event that you submit your requests regarding your rights specified above to our Company, our Company will conclude the request as soon as possible and at the latest within thirty days free of charge. However, if the transaction requires an additional cost, our Company may charge a fee according to the tariff determined by the Personal Data Protection Board.
